Revenue Cycle - Subject

The appeal period begins with the date of the denial notice plus an extra five days for the time it take for the beneficiary to receive the notice. Therefore, the total timeframe for requesting an appeal for a cessation of disability benefits is 65 days. As long as an individual appeals their disability cessation, there is a chance that their cessation could be overturned at a state disability agency hearing or at an administrative law judge disability hearing.

How to Win Your VA Compensation Appeal

Complete the appeal form as soon as possible after you receive your benefits denial notice from the department of labor. Return it to the appeals board at the address listed on the form within the expiration time line. You will receive an appeal hearing notice from the appeals board with the hearing's date and location.

Request an appeal in a timely manner. While your case is still relatively fresh, it is wise to keep things moving expeditiously by filing an appeal as soon as your application has been rejected. You should file an appeal within 60 days of receiving a denial or you will risk being required to file your disability application from scratch.
